Resident and Non-Resident Enrollment

- Total enrollment is up 7% and total FTES is up 6%.
 - Total FTES increased by 284 from 4,370 to 4,654.
- Resident enrollment and FTES are up 5% each.
 - FTES increased by 191 from 3,932 to 4,123.
- Non-resident enrollment is up 20% and FTES is up 21%.
 - FTES increased by 94 from 438 to 531.

Resident and Non-Resident Enrollment by Category

- Among the resident category, the increase to its overall FTES was driven by the overall resident subgroup, which had 195 more FTES than compared to last year. Some categories saw a decline including AB 540, AB 2364 Dual Enrollment and Non-Resident Fee Exempt.
- Among the non-resident category, increases in FTES were driven by growth of the non-resident, international subgroup which increased by 86 FTES, for a 27% increase.

International Students with F1/FZ Visa

- Headcount of students with F1 or FZ visas increased from 921 to 1,134, representing a 23% increase in F1/FZ visa students from last fall quarter.

Ethnicity

- All student ethnic groups saw an increase in headcount and FTES with the exception of Filipinx which saw a decrease in enrollment but an increase in FTES which indicates there are fewer overall students but those enrolled are enrolled in more units.
- The largest increase in FTES was observed for Latinx (94) followed by Decline to State students (83), white (38) then Asian (36).

- Students with an educational goal other than transfer, degree, or certificate is at 22%. The “all other” category includes vocational training and job recertification.

City of Residence

- The majority of students reside in San Jose (7,889), followed by Sunnyvale (1,672), Cupertino (1,315) and Santa Clara (942).
- San Jose saw the largest decrease in students with a loss of 393 or a 5% decrease while Sunnyvale saw the largest increase in headcount with an additional 309 students for a 23% increase followed by Outside California with an increase of 156 students.
